OBJECTIVE OF INTERNAL COMPLAINT COMMITTEE

It is dedicated to create an environment on the campus where every female feels safe.

The objectives of the women's grievance cell are as follows:

- To create awareness amongst students about the problems faced by women due to gender issues.
- 2. To create an environment of gender justice where men and women work together with a sense of personal security and dignity.
- To create awareness amongst students about the issues related to the youth, girls in particular
- 4. To disseminate knowledge about rights and laws related to women.
- 5. To enhance the self-esteem and self-confidence of girl students, women faculty and staff.
- 6. To foster decision-making ability in girl students for making informed choices in areas like education, employment and health.
- To examine all grievance letters received from the women staff / students regarding the sexual harassment.
- 8. To examine and investigate on each complaint received from the women staff / students by collecting the required information / data from connected people.
- To give feedback to the women staff / students concerned / to find solution for their grievances.
- 10. The committee will record such grievances received from the women staff / students, in a separate register maintained exclusively for this purpose. The reply given by the committee to the women staff / students for grievance should also be recorded in the register.
- 11. The Committee should find suitable solutions to settle the problems faced by the women staff / students in regard to matters relating to sexual harassment within 10 days' after thorough investigation.
